

# French solar container battery project



## Overview

---

A 20-foot mobile solar container with 50 kW capacity now costs €52,000 - down 18% since 2022 due to Chinese battery price drops. When paired with France's 40% tax credit for commercial solar (CITE) and €0.28/kWh feed-in tariffs, the payback period shrinks to 4-6 years.
