Whether you push all the branches or just some of them, Git will perform the entire operation without creating any new local branches, and without making changes to your working

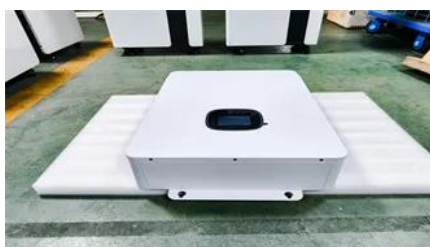
